In brief

Workers' compensation is a form of insurance payment to employees who are injured at work or become sick due to their work. WorkSafe manages Victoria's workers' compensation scheme.

Employers are required to register for workers' compensation insurance or be an approved self-insurer in Victoria if they either hire apprentices or pay more than \$7,500 in a financial year in remuneration to employees.

Victoria's publicly stated average workers' compensation premium rate was unchanged from 2014–15 to 2022–23 at 1.272% of total remuneration. In May 2023, the Victorian Government announced the rate would increase to 1.8% in 2023–24, an increase of 41.5%.

We compare Victoria's average premium rate to other Australian states where workers' compensation schemes are managed by one agency – New South Wales, Queensland and South Australia.

Notes: There are differences among these states in how the premium rates are applied and, by extension, the burden they have on businesses. Each of these states applies premium rates to some definition of remuneration or wages. While there are differences between these states, they all include payments such as salaries, superannuation, fringe benefits and leave.

Victoria has exhibited the largest nominal increase in publicly stated average premium rates from 2018–19 to 2023–24. In 2023–24, Victoria has a higher publicly stated average premium rate than New South Wales and Queensland, and a lower rate than South Australia.

Each state is structurally different, with different mixes of industries. High-risk industries, such as some mining related activities, are subject to a higher premium rate. The extent to which these kinds of industries are prevalent in a state will affect how the rates impact the average business.

Additionally, premium rates in these states are estimated based on remuneration. For each state remuneration includes payments such as salaries, superannuation, fringe benefits and leave. These states use a similar, but not the same, definition for remuneration. For a given rate, a narrower definition of remuneration would result in a lower premium for a business.

Given the structural differences in state economies and in the definition of remuneration, it is impossible to determine the relative burden of premiums across states using public information.



Context

Request

On 13 July 2023, Mr John Pesutto MP, Member for Hawthorn, asked the Parliamentary Budget Officer to provide independent advice about Victorian workers' compensation premium rates, and how it compares with other states.

Scope

In this advice we compare Victoria's publicly stated average workers' compensation premium rates to other Australian states where workers' compensation schemes are managed by one agency – New South Wales, Queensland and South Australia. This advice does not consider Western Australia, Tasmania, the Australian Capital Territory or the Northern Territory, where workers' compensation schemes are not managed by one agency. Employers in these states and territories are required to either self-insure or be insured for workers' compensation with a licensed insurer.

We consider the publicly stated average rates from 2018–19 to the current financial year (2023–24).

Limitations

We compare publicly stated average workers' compensation premium rates between states. This analysis does not compare the average premiums actually paid by employers, which vary across states depending on how the premium amounts are calculated. We do not consider differences in the underlying methods and assumptions that each state uses to determine its average workers' compensation premium rates.

Each state also applies different discounts and surcharges to premium rates paid by employers, for example the Dust Diseases contribution in New South Wales. It is unclear whether the publicly stated average premium rates account for all discounts and surcharges, and these may differ across states.

Additionally, we do not account for the different proportions of high-risk and low-risk jobs across states when comparing premium rates, but do include premium rates by industry for Victoria in Attachment A.

We make no judgement on the effectiveness of premium rates to sufficiently cover workers' compensation claims.

We prepared this advice on 24 July 2023.

Background

Workers' compensation is a form of insurance payment to employees who are injured at work or become sick due to their work. WorkSafe manages Victoria's workers' compensation scheme.

In Victoria, the workers' compensation premium amount is generally equal to the specified premium rate, multiplied by the total expected remuneration paid in a financial year less a specified deductible amount (\$15,500 in 2023–24). Remuneration is the total amount of benefits paid to workers, which includes wages, salaries, superannuation, and other benefits.

The premium rate differs for each industry, and a weighted rate applies for employers that operate in multiple industries. The premium rate for a specific employer can differ from the industry rate, based on the employer's claim history relative to its industry and size.



WorkSafe applied a capping factor of 1.75 to employer's premiums in 2023–24, which means that the premium rate for an employer could not increase by more than 75% from 2022–23 to 2023–24. There is also a minimum premium that each employer must pay, which is equal to \$330 in 2023–24.

An employer can receive a discount if it pays the premium early. These discounts are:

- 5% if the premium is paid by 14 August 2023
- 3% if the premium is paid by 1 October 2023.

The annual premium due date is 1 November 2023, although employers have the option to pay monthly or quarterly instalments from October 2023.

Employers have the option to self-insure, which means that they bear the cost of any workers' compensation claims. An employer needs to apply to WorkSafe Victoria to be eligible for self-insurance. For an employer to be eligible, it must:

- be a body corporate, and not a subsidiary of another body corporate
- satisfy minimum requirements regarding financial strength and viability, demonstrating that it is capable of meeting claims liabilities.

Self-insurers are typically large employers. Employers that are required to have workers' compensation insurance are also required to choose an agent appointed by WorkSafe to manage insurance and claims on their behalf.

Average premium rates

In this section

This section compares the publicly stated average workers' compensation premium rates across all Australian states where the workers' compensation scheme is managed by one agency.

Victoria

Victoria's publicly stated average premium rate is 1.8% of total remuneration in 2023–24. WorkSafe Victoria advises that remuneration includes payments such as salaries, superannuation, leave and fringe benefits, and excludes payments such as:

- lump sum termination payments
- payments from/to schemes other than workers' compensation.




Figure 2 - Victoria's publicly stated average premium rates

Victoria's publicly stated average premium rate was unchanged at 1.272% from 2018–19 to 2022–23. Prior to the increase in 2023–24, Victoria's rate was last changed in 2014–15, when it was reduced from 1.298% to 1.272%.

The increase in 2023–24 impacts each industry differently. A comparison of each industry's rates in 2022–23 and 2023–24 is provided at Attachment A. In 2023–24, 4 industries have premium rates above 10%:

- Other Non-Metallic Mineral Product Manufacturing 18.000%
- Tiling and Carpeting Services 14.090%
- Other Horse Racing Activities 11.043%
- Stevedoring Services 10.152%.



New South Wales

New South Wales' publicly stated average premium rate is 1.6% of total wages in 2023–24. Insurance and Care NSW, the New South Wales government agency which sets rates, indicates that wages include payments such as salaries, superannuation, leave and fringe benefits. It notes that wages exclude payments such as:

- payments to non-working directors
- compensation payments under the Workers Compensation Act 1987.




Figure 3 – New South Wales' publicly stated average premium rates

New South Wales' publicly stated average premium rate has also increased in each year from 2020–21 to 2023–24. Prior to the increase in 2021–22, the average rate was 1.4% in each year since at least 2015–16.

Queensland

Queensland's publicly stated average premium rate is 1.29% of total wages in 2023–24. WorkSafe Queensland indicates that wages include payments such as salaries, superannuation, leave and fringe benefits. It notes that wages exclude payments such as:

- any amounts reimbursed for work-related expenses
- lump sum termination payments
- excess period payments
- any compensation payment reimbursed by WorkCover
- any payment made to Directors, Trustees or Partners.

Queensland's publicly stated average premium rate has increased in each year from 2021–22 to 2023–24. Prior to the increase in 2022–23, the rate was 1.2% in each year since at least 2016–17.

South Australia

South Australia's publicly stated average premium rate is 1.85% of total remuneration in 2023–24. Return to Work South Australia indicates that remuneration includes payments such as salaries, superannuation, leave and fringe benefits. It notes that remuneration excludes payments such as:

- income support paid as a result of a compensable injury
- lump sum termination payments.




Figure 5 - South Australia's publicly stated average premium rates

South Australia's publicly stated average premium rate has increased in each year from 2020–21 to 2023–24. The average primum was 1.65% in 2019–20 and 2020–21, which was the lowest rate in the history of the WorkCover and Return to Work schemes in South Australia.
